Re: Notice of Street Closure - Lacewood Dr

As part of the New Seton Ridge Development, with works being completed by Dexter Construction, on behalf of Southwest Properties, construction work will be occurring on Lacewood Drive, at the intersection of **Lacewood Drive and Cedarbrae Ln**. The work being done is in relation to the underground services tie-in for the New Development. This will result two separate street closures, which will take place at the following times:

- Starting at 6:00PM on Thursday, August 21st, and ending at 6:00AM on Friday, August 22nd.
- Starting at 8:00AM on Saturday, August 23rd, and ending at 6:00PM on Sunday, August 24th.

All vehicular traffic travelling outbound up Lacewood Drive, including Bus routes, will be detoured onto Clayton Park Dr and Dunbrack St. All inbound traffic travelling down Lacewood Drive will be detoured onto Dunbrack St, Willett St, Main Ave, and Titus St. Access to Cedarbrae Drive will be maintained from the lower side of the closure (Bayview Rd side).

If you live in the affected area, you will maintain vehicle access to your driveway for the duration of this street closure. Access will remain open from either end to local residents.

This work is weather dependent, and the street closure may be extended if inclement weather delays this work from happening. Should this occur, you will be provided written notice of an extension in the street closure in advance.

We apologize in advance for any inconvenience this may cause you and thank you for your co-operation during this construction.

Re: Shutdown for planned maintenance – Lacewood Drive

Dexter Construction wishes to advise the water consumers on Lacewood Dr that the water will be turned off on Thursday, August 21st, 2025 at 9 pm for approximately 9 hours and continuing until Friday, August 22nd, 2025 at 6:00 am the following morning.

The following are things to keep in mind during this water shut down:

- To ensure that you have water during this period, please fill any empty containers you own so that you will have sufficient water to facilitate toilet flushing, drinking, cooking and other.
- It is also advised that you shut off your hot water heater during the duration of the shutdown to avoid back siphonage.

If you experience discoloured water, run the COLD water at one faucet for about 10 minutes. You should see the water clear. Do not use the hot water faucet since this will draw discoloured water into your hot water heater/tank, which could make the problem worse.
